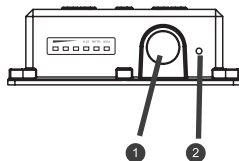

3 Install the radio

Instructions before installing

- Locate a suitable place and adjust the device angle facing to the target area.
- You may need a clear line-of-sight condition.
- Do not install in illegal places to avoid violating the local regulatory rules.
- The pole for installing should be $\Phi 30$ -60mm.
- You may need tools below.

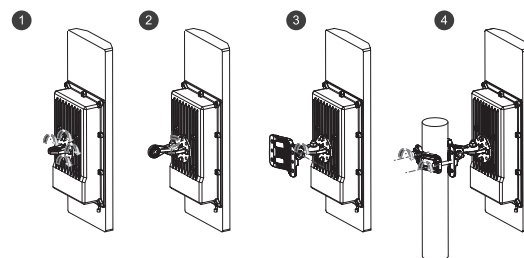

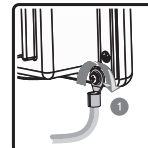
Waterproof tape

Install the radio



- 1 Put the small bracket aiming at 4 screw hole on the back of the device, place and tighten the screw.
- 2 Aim the connection bracket through the small bracket, tight with M8*40 screw.
- 3 Aim another hole of the connection bracket with the mounting bracket, tight with M8*40 screw.
- 4 Mount the device on a pole which should be less than $\Phi 80$ mm, and tight with another mounting bracket using M8*60 screw.

Connect the cable



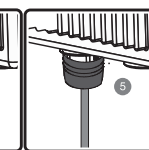
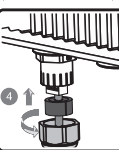
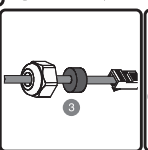
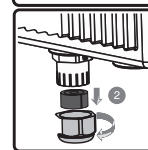
- 1 Connect the ground cable.

- 2 Screw out the waterproof cap.

- 3 Pass the RJ45 cable through the rubber ring and cap.

- 4 Screw back the cap tightly, mounting bracket using M8*60 screw.

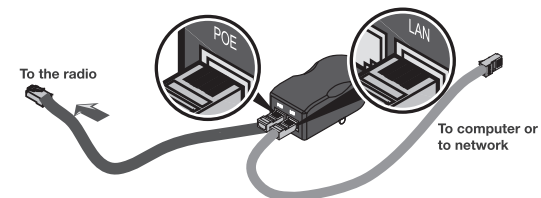
- 5 Use waterproof tape to cover the cap.



ATTENTION

Shielded Category 5 (or above) cabling should be used for all wired Ethernet connections.

Power up the radio



Connect one end of an Ethernet cable to the **POE** port of the provided PoE DC Adapter and the other end of the Ethernet cable to the RJ45 port of the device. Then, connect the **LAN** port of the PoE DC Adapter to a PC or switch using another Ethernet cable. Finally, plug the PoE DC Adapter into a standard electrical wall socket.

If you use other PoE Adapter which is not provided by Wisnetworks, we can't provide warranty service if device damage caused.

4 Web configuration

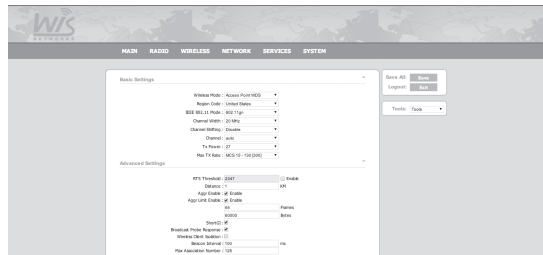
1. Check all wires are correctly connected.
2. Configure the host system with static IP on the 192.168.1.x (x could be 10~254) subnet.
3. Using a web browser access 192.168.1.2 (wait a few seconds after device power up).
4. When login page appears enter "admin" in both the username and password fields.
